Payment will be made once required documents (receipt(s) and W-9) are provided.
- 5. A reimbursement payment must be greater than or equal to \$100. Applicants are welcome to submit multiple receipts for approved expenses to meet the \$100 minimum.
- 6. Multiple applicants cannot combine grant reimbursement to cover the same expense.
- 7. Funds will be awarded on a first come, first serve basis.
- 8. GreenStone Farm Credit Services reserves the right to make decisions on a case-by-case basis, and to allocate grant funds as needed.
- 9. GreenStone Farm Credit Services reserves the right to alter our decision if the submitted grant use receipt(s) does not match what is outlined in the approved grant application and/or if intended use does not meet grant criteria.
- 10. Relatives (spouses, siblings, step-siblings, children, step-children, grandchildren, step-grandchildren, nieces, nephews, etc.) of GreenStone Farm Credit Services board directors and/or employees are not eligible to receive funds.

Qualifications, Grant Use and Exclusions

- Young, beginning or small farmer:
 - o 18-35 years of age, or
 - o Farming for less than 10 years, or
 - O Sustain annual gross sales from agricultural production of less than \$250,000
- Must be eligible to be a member of GreenStone Farm Credit Services; reside in Michigan or northeast Wisconsin.
- Intended grant use must fall within one of the following categories:
 - o Agricultural programs/events: educational course/program (on-site or online), conference fees, etc.
 - Program/event must support agricultural business Program/event not required to be in GreenStone's territory
 - O GreenStone resources: accounting, payroll or tax planning and preparation Available only for first time use of GreenStone financial services
 - o Non-GreenStone services: business and farm consultants, etc.
- Exclusions of grant use includes:
 - Entertainment venues/networking events
 - Travel related expenses
 - O Costs for participants beyond the primary young, beginning, or small farmer
 - Subscription and/or membership costs
 - O College course as part of a degree program
 - O Technology software and hardware, farm equipment, farm inputs/operating expenses, building improvements, etc.
 - Family and personal financial planning or legal fees
 - Routine business costs (yearly taxes, etc.)
 - Previously reimbursed events/resources/services to repeat applicant
 - External support for services offered by GreenStone Farm Credit Services
 - Costs associated with loans, fees, etc.
 - O Costs associated with the Farm Women's Symposium Due to scholarships available directly through the program
